NOTE: Spots can become set after steam extraction or other carpet treatments. This may require additional application and sponging or may cause failure of this product.

### USAGE

Recommended for industrial, commercial, institutional as well as household use. For spots and stains of coffee, tea, soft drinks, alcoholic beverages, Kool-Aid®, oil, grease, mud, ketchup, urine, ink and more.

### DIRECTIONS

SHAKE WELL BEFORE USING. Test first for color fastness.

Can will spray in inverted position only. Hold can in inverted position at arms length, pointed directly at the spot to be cleaned. Spray spot, watch spot disappear. Excessive deposits of grease, ink or oil may require additional applications or agitation. If spot is saturated, it is best to blot area with sponge or paper towel. Allow surface to dry before determining need of second application.
